**Subject:-Implementation of NFSA. (Preparatory steps thereof)**

Sir,

I am directed to invite your kind attention towards the minutes of meeting held under the chairmanship of Hon'ble Prime Minister of India Sh. Narinder Modi on 30-09-2015 via video conferencing under PRAGATI communicated by the Planning & Development Department vide No.PD/CSS/PRAGATI/2015 dated:16-10-2015 and in light of next review to be held on 30-10-2015 you are requested to furnish the following information within 3 days positively so that the tentative status regarding implementation of NFSA can be debated in the Scheduled PRAGATI review


- a) Status of accurate database of total number of Ration Tickets i.e of 74.13 lakh souls priority households comprising of AAY & BPL category and non-priority (APL) of around 45 lakh souls seeded with genuine identity proofs like Aadhaar, EPIC etc. and its hoisting on relevant portal created by the NIC.
- b) The Directors shall ensure 100% fidelity by doing the de-duplication, necessary weeding for creation of 100% accurate database within a period of 15 days from issuance of this order and for submission of hard copies to the Adm. Department as well.
- c) May also take up with the concerned District Development Commissioners to revisit their survey analysis as per census 2011 for effecting necessary additions, deletions or rectification to avoid non inclusion of bonafide beneficiaries within a period of 15 days and submission of requisite information in this connection to the Adm. Department.



- d) Director CAPD Kashmir designated as Nodal Officer for publication of ration cards shall ensure the necessary rectification to be made with respect to ration cards in view of the NFSA requirements and the communication of progress achieved in this behalf to the Adm. Department within stipulated time.
- e) Directors may direct their Chief Accounts Officers to prepare fresh Budget Estimates for the next financial year (2016-17) and Revised Estimates for the year 2015-16 as per the requirements of implementation of NFSA including cost price, handling commission etc. so that the same can be made available to the Finance Department within 3 days for discussion at the relevant point of time.
- f) Being the implementation agencies, the Directors are requested to go through all the sections/provisions/guidelines of the act again and feel free to share their recommendations/suggestions with the Administrative Department if any.
