The appointee shall however be allowed to join only on production and verification of the following documents/certificates in original by Director, Consumer Affairs and Public Distribution Department, Kashmir:-

1. Academic/Technical Qualification certificates.
2. Age and Matriculation/date of birth certificate.
3. Health Certificate issued by the Chief Medical Officer.
4. Permanent Resident Certificate issued by the Competent Authority.
5. No Loan certificate under Self-Employment scheme from Industries/Employment Department.
6. Legal heir Certificate issued by the competent authority.

The order of appointment shall be subject to cancellation ab-initio, in case, at any stage, it emerges that the certificates/documents furnished by the appointee are fake/fictitious.

The salary of the appointee shall be drawn and disbursed only on receipt of a satisfactory report about the verification of the character antecedents from Inspector General


