Subject:- Constitution of "Flying Squads" for Market Checking.

Government Order No :- 13 -CAPD of 2015
Dated :- 12 - 03 - 2015

Whereas Consumer Affairs & Public Distribution Department is entrusted with the job of supply chain management and prevention of black marketing, hoarding and profiteering of essential commodities.

Whereas complaints are invariably pouring in from the Districts regarding unfair trading practices being adopted by the unscrupulous traders, shopkeepers, vendors etc. by indulging in hoarding, profiteering, black marketing and overcharging of essential commodities and thus fleecing the public at large.

Whereas also the complaints of providing/issuing less foodgrains and poor quality grains have been preferred from certain quarters.

Therefore, in order to lay a check and control over hoardings, profiteering and black marketing of essential commodities and to prevent/check unscrupulous trading practices in all the Districts of Jammu and Kashmir, sanction is hereby accorded to the constitution of "Flying Squads" with the following composition which shall work under the supervision of the Deputy Commissioners of the concerned Districts.

The squads shall be responsible for enforcement of rates, and overall control and regulation of supply and availability of Essential Commodities.

The Deputy Commissioners/DDCs of the respective Districts shall keep the Secretary, Consumer Affairs & Public Distribution Department apprised of the progress about the market checking on monthly basis.


