Whereas, Shri Pamposh Ganjoo, Section Officer, Food Civil Supplies & Consumer Affairs reportedly applied for five day's casual leave on 07-08-2018 w.e.f 08-08-2018 onwards;

Whereas, the casual leave applied by Shri Pamposh Ganjoo, Section Officer was not sanctioned by the authorities;

Whereas, despite the fact that leave has not been sanctioned by the authorities, Shri Pamposh Ganjoo, Section Officer left the station without station permission;

Whereas, J&K Civil Service (Leave) Rules 1979, Chapter II rule 8(i) prescribes for that leave cannot be claimed as a matter of right and rule 8 (ii) when the exigencies of Public service so require, leave of any kind may be refused or revoked by the authority competent to grant it;

Now, therefore, pending enquiry into his conduct, Shri Pamposh Ganjoo, Section Officer, Department of Food, Civil Supplies & Consumer Affairs, Civil Secretariat, is hereby placed under suspension, with immediate effect, for unauthorised absence from duties and leaving the station without permission. During the period of his suspension, he shall remain attached in the office of Deputy Director (Planning).
