- 1) Whereas, eight new District Consumer Fora have been established under the Jammu and Kashmir Consumer Protection Act, 1987; and
- 2) Whereas, eight posts of Junior Scale Stenographers and eight posts of Junior Assistants have been created under Government Order No.36-CAPD of 2010 dated 27.04.2010 for these newly established eight District Consumer Fora; and
- 3) Whereas, no method of recruitment and conditions of service has so far been prescribed for these newly created posts; and
- 4) Whereas, these posts are to be filled up as early as possible to facilitate smooth working of the newly established eight District Consumer Fora; and
- 5) Whereas, in absence of the method of recruitment these posts can not be filled up; and
- 6) Whereas, it has been deemed appropriate to adopt the method of recruitment and conditions of service prescribed under the Jammu and Kashmir, Secretariat (Subordinate) Service Rules, 1998 for filling up these vacancies of Junior Scale Stenographers and Junior Assistants.

Now, therefore, the method of recruitment and the conditions of service prescribed under the Jammu and Kashmir, Secretariat (Subordinate) Service Rules, 1998 are hereby adopted for the newly

created eight posts of Junior Scale Stenographers and eight post of Junior Assistants create under Government Order No:- 26 -CAPD of 2012 dated: 12-03-2011.
