- vi) Certificate from the General Manager DIC concerned and Deputy Director Employment concerned to the effect that no loan under self employment schemes has been taken.

Their appointment shall be subject to the following conditions :-

- a) each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID J&K, to whom a reference shall be made by the CAPD Department, the candidate shall have no right to claim his/her appointment as Assistant Controller and his/her appointment as such shall be deemed to have been cancelled ab-initio.
- b) Verification of the qualification certificate/reserved category certificates (wherever applicable) from the concerned issuing authorities.

Salary of these appointees shall not be drawn and disbursed to them unless positive/satisfactory report in respect of (a) and (b) above is received.

The appointees shall be on probation for a period of two years. Their inter-se-seniority shall be notified separately.




