Subject: ***Suspension of Mr. Irfan Bahadur, Assistant Director,  
CA&PD, Kupwara.***

**Government Order No. 32 - CAPD of 2014  
Dated: 23 .05.2014**

During the course of meeting at Kupwara in the recent past followed by meetings at Srinagar in the month of March, 2014 and May, 2014 respectively, certain directions were given to Assistant Director, CA&PD, Kupwara for improving the availability of foodgrains in district Kupwara as per the requirement;

Whereas, in order to overcome the crises, it was decided that advance stocking shall be made to cover the gap and also whereas in view of the food crises in District Kupwara, an additional 8000 qtls of foodgrains was arranged for distribution by the Director for meeting the requirement in such areas of the district where the crises was blatant;

Whereas, the Assistant Director, CA&PD, Kupwara, instead of complying with the instructions, slept over the issue which resulted in serious outcry in the district as a whole;

Whereas, the Director, CA&PD, Kashmir was instructed to furnish Centre-wise statement indicating the availability and dispatch of foodgrains in District Kupwara;

Whereas, the Director, CA&PD, Kashmir vide his office No. DCAPDK/PS/2014/2966 dated 12.05.2014 furnished the Statement of district Kupwara, duly signed by the Assistant Director, CA&PD, Kupwara indicating the Centre-wise position of foodgrains as on 12.05.2014;

Whereas, the perusal of the Statement provided by the Director CA&PD, Kashmir reveals discriminatory stocking by the Assistant Director, CA&PD, Kupwara, as the said Officer has provided 756.30 qtls of foodgrains as excess in 80 No. of Centres, over and above the requirement, and enough shortfall of 7137.24 qtls in 198 No. of Centres. This irrational and discriminatory stocking is a serious lapse on the part of the Officer;

Now, therefore, pending inquiry, Mr. Irfan Bahadur, Assistant Director, CA&PD, Kupwara is hereby placed under suspension with immediate effect. During the period of suspension, the suspendee shall remain attached with the Directorate of Consumer Affairs & Public Distribution, Kashmir.


