Whereas, the Department of Food Civil Supplies & Consumer Affairs is entrusted with the duties to distribute the PDS items at subsidized rates to the entitled beneficiaries in terms of NFSA; and,

Whereas, the Department of FCS & CA vide Govt. Order No.129- CAPD of 2015 dated:-04-12-2015 has constituted a committee with a view to identify the priority households under NFSA, , and

Whereas, as per criteria laid down under Govt. Order No.128-CAPD of 2015 dated:-04.12.2015, all the then existing AAY category families were brought within the ambit of proviso to the sub-clause (1) of section 3 of NFSA; and

Whereas the then existing AAY families were identified at the time of implementation of AAY Scheme among the families belonging to the poorest among the poor categories and,

Whereas, the Department is receiving complaints in respect of identification of the entitled beneficiaries under section 3 of NFSA; and

Therefore in view of the above stated facts the sanction is hereby accorded to the committees already constituted vide Govt. Order No.129-CAPD of 2015 dated:-04.12.2015 to re-verify the AAY families in terms of the guidelines notified by the Govt. of India in this behalf. The Committees shall submit its report within a period of fifteen days.
