Subject: ***Suspension of Mr. Reyaz Ahmad Malik, TSO
Pulwama Godown***

**Government Order No. 36 - CAPD of 2014
Dated: 03.06.2014**

Whereas, Assistant Director CA&PD, Pulwama vide his office letter No. CA&PDD/Pul/2014/4087 dated 17.05.2014 addressed to Director, CA&PD, Kashmir has intimated that one Mr. Reyaz Ahmad Malik, presently posted as TSO Pulwama Godown is involved in excess issuance of foodgrains to the tune of 7228 Qtls (rice) for the period 2009-10;

Whereas, the said official was also involved in the similar irregularity in the year 2002-03, and the records for the said period have been misplaced;

Whereas, the said official, as reported by the Assistant Director, CA&PD, Pulwama, has also issued excess quantity of Rice and Atta to Nawa/Kakapora circles in the month of February, 2014;

Whereas, despite seeking an explanation from the concerned, as intimated by the Assistant Director, CA&PD, Pulwama, the said official has continued with the said practice without any authority for the month of March, 2014 as well, thus indulging into the misappropriation of foodgrains by way of issuing excess quantity of foodgrains;

Whereas, the Employee's Union of District Pulwama have also expressed serious concern against the said official, who is a habitual offender and have demanded stern action against the concerned;

Whereas, the Assistant Director, CA&PD, Pulwama has further intimated that till date, the official is moving scot-free and going loose without having been asked to explain his position or without any action having been taken against the official;

Now therefore, pending inquiry by the Director, CA&PD, Kashmir, Mr. Reyaz Ahmad Malik, TSO, Pulwama Godown, is placed under suspension with immediate effect and attached with the Directorate of CA&PD, Kashmir.

The Assistant Director, CA&PD, Pulwama shall immediately take immediate possession of entire record of the circle and hand over the same to the TSO of adjoining circle till further arrangements are made in this regard by the Directorate.

It is further ordered that inquiry shall be completed by the Director, CA&PD, Kashmir within a timeframe of fortnight and on the basis of records, whatever shortages is proved against the official, shall be recovered from the concerned by way of attachment/sale of his property as arrears of land revenue by taking up the matter with the Deputy Commissioner concerned, if he fails to liquidate it within one week from the date of issuance of notice to be served upon him immediately after establishing the outstanding.
