In pursuance of Govt.Order No. 52-PD OF 2017 dated:-09-02-2017 issued by the Planning Development and Monitoring Department under endorsement No. PD/2016-17/Coord-101/CF/28 dated:-09-02-2017, sanction is hereby accorded to the release of **Rs. 100.00 lacs (Rupees one hundred lacs only)** under the scheme Construction of Director CAPD Office, Jammu of Capex Budget 2016-17 in favour of Director, Department of FCS&CA Jammu for further placement at the disposal of Managing Director J&K Housing Board along with **advance drawal** for utilization during the year 2016-17.

The release of funds shall be subject to the following terms and conditions:

- 01.All necessary Administrative Approvals and Technical Sanctions shall be obtained prior to the execution of works/projects. In case of cost revision, necessary revised Administrative Approval shall be obtained from the Competent Authority for incurring expenditure.
- 02.The expenditure shall be restricted to the administratively approved cost of the project /work only.
- 03.The funds released shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules.
- 04.No diversion of funds is allowed.
- 05.Scheme/projects already taken up shall have to be completed in maximum of two or three years time.
- 06.The progress achieved under the Scheme both in terms of Physical/ financial shall be communicated to the Administrative Department by 1st of each month.


