Sanction is hereby accorded to the release of funds to the tune of Rs. 6.25 lacs (Rupees Six lacs and twenty five thousands) only representing remaining 25% of the approved outlay under Capex Budget 2015-16 under the scheme "**Construction of Director CAPD Office Jammu**" and placed at the disposal of Director CA&PD Department Jammu for further payment to JKPC or PWD as per Govt. order no. 47-PW(R&B) of 2013 dated: 19.02.2013 for utilization of the funds for the said work during the current financial year 2015-16. The total funds released under the Scheme ("**Construction of Director CAPD Office Jammu**") aggregate to Rs. 25.00 Lacs under Capex Budget 2015-16.

The release of funds shall be subject to the following terms and conditions:

1. That the funds released shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules.
2. It is Mandatory that the necessary Administrative Approval of the work has been accorded and technical sanction is obtained from the competent authority prior to execution of the work.
3. No diversion of funds is allowed.
4. The progress achieved under the Scheme both in terms of Physical/ financial shall be communicated to the Administrative Department by 1st of every month.


