
Whereas, a Public Interest Litigation tiled "Sheikh Mohammad Shafi Vs UOI and Ors was under adjudication before the Divisional Bench of the Hon'ble High Court and the Hon'ble High Court directed the State Government to file the action taken report (ATR) with regard to departmental enquires against the various gazetted Officers alongwith the complete particulars of these Officers;

Whereas, the Director, Consumer Affairs and Public Distribution Department, Kashmir was requested to conduct an enquiry and furnish his findings;

Whereas, no report has so far been received from the Director, Consumer Affairs and Public Distribution Department, Kashmir as a result of which the Action Taken Report to General Administration could not be filed;


