In pursuance to Revenue Department's Government order No: Rev/ER/273 of 2014 dated 31-10-2014., sanction is hereby accorded to release of the funds in favour of Director CA&PD Jammu/Kashmir for lifting of the additional allocation of food grains for flood affected families of the State for six months w.e.f. months September, 2014 and the expenditure on this account shall be classified as under:-

The funds released above are subject to the following conditions:

1. The amount is sanctioned strictly in accordance with the norms and guidelines of the Government of India.
2. The funds shall be drawn from the Treasury only as and when the occasion demands.
3. The Funds drawn are not parked in any bank account outside the State Account.
4. The utilization certificate as required under SDRF norms shall be furnished by the concerned at the close of each month.
5. The claim shall be settled to the condition that they are sanctioned by the competent authority as per the delegation of SOP issued vide Government Order No: Rev/ER/70 of 2014 dated 18-03-2014.
6. The food gains procured against this allotment shall be strictly distributed among the additional flood victims possessing no ration tickets as verified and declared as flood hit families in the assami wise list prepared and authenticated by the concerned Deputy Commissioner's as per Govt: Order mentioned above issued by Revenue Department.
7. Deviation of aforesaid conditions if any shall invite strict action.
