**Subject: Monitoring, Supervision and Regulation of functioning of Auto Rickshaws / Cabs -  
Constitution of Committee thereof.**

**GOVT. ORDER NO: - 94 -CAPD OF 2015**  
**D A T E D: - 27 - 08 - 2015**

Sanction is hereby accorded to the constitution of a Committee headed by Transport Commissioner J&K with the following Officers as Members to conduct, monitor and supervise the functioning of the Auto Rickshaws, Taxis, Cabs and other service providers in this sector with regard to the installation / functioning of fare meters. The Committee shall comprise of:-

1. Transport Commissioner J&K (Chairman)
2. Deputy Inspector General of Police (Traffic) Srinagar / Jammu. (Members)
3. Commissioner Municipal Corporation Jammu / Srinagar (Members)
4. Joint Controller Legal Metrology Department Jammu / Kashmir (Members)
5. Regional Transport Officer Jammu / Kashmir (Members)
6. Representatives of Taxi / Auto Rickshaw Unions (to be nominated by Chairman of the Committee) (Members)

The Committee is authorized to cancel the Route Permits of the vehicles of the defaulters or take any other action which the team may deem expedient to serve as a deterrent to the unfair practices being adopted by unscrupulous operators. Besides taking other necessary steps the Committee shall ensure the display of Fare Charts / Installation of Functional Fare Meters duly calibrated by the Legal Metrology Department on all the Auto Rickshaws / Cabs to prevent the unnecessary fleecing of commuters at the hands of unscrupulous operators.

The Committee shall also ensure that no Calibration Certificates / Fitness Certificates are issued to the operators plying without the installation of functional Fare Meters.


