Sir,

I am directed to convey the monthly allocation of food grains (Rice and Wheat) for the first six months of the year 2016-17 i.e from April 2016 to September, 2016 under Welfare Institutions Scheme in favour of Director CAPD Jammu/Kashmir as per the details indicated below:

The above allocation under Welfare Institutions Scheme shall be subject to the following conditions:

1. Both the Directors shall obtain the list of orphanages and other welfare Institutions with in a week's time from the date of issue of this letter and get them approved from Administrative Department (CAPD) for release of allocation of 2nd half of the year 2016-17.
2. The validity period for deposit of cost and lifting of food grains for the month of April, May, June and July 2016 will be up to 45 days and 50 days respectively from the date of issue of the allocation letter of the Government of India dated:-18-07-2016 (copy enclosed) and for the subsequent months of August,

2016 to September, 2016 will be as per instant instructions of the concerned Ministry of Govt. of India.

3. All other conditions laid down by the Government of India and by this Department vide letter No. CAPD/Plan/45/2011 dated 22-02-2012 shall be complied by the Directors CAPD Jammu/Kashmir.
4. The Director CAPD Jammu/Kashmir shall ensure that the food grains under the scheme is distributed to all eligible welfare institutions registered as per rules currently in vogue so as to avoid any misuse of the food grains.
5. The Director CAPD Jammu/Kashmir shall furnish utilization certificates for the 1st half of the year 2016-17 immediately after the close of the month of September, 2016 strictly as per format GFR 19-A for its further submission to Govt. of India.
