Whereas, in the interest of Administration various transfers and postings of Assistant Controllers Legal Metrology Department were made vide Government Order No.64 Of 2014 Dated:04-09-2014.

Whereas, above said transfer Order Dated:04-09-2014 has been challenged before the Hon'ble High Court by virtue of SWP No.2498/2014 titled Anita Sharma V. State and Others.

Whereas, the Hon'ble High Court vide Order dated:-12-09-2014 has passed an interim direction, the operative part whereof reads as under:-

Meanwhile, given that the transfer is premature, as ad interim, subject to objections and till next date before the Bench, the impugned transfer order dated:04-09-2014 qua the petitioner shall stay and petitioner shall continue as Assistant Controller, samba, whereas respondent no.2 shall report to a Divisional Level Office of the department at Jammu. It shall, however, be open for the official respondent to issue fresh order as regards posting of respondent No.2 notwithstanding pendency of this writ petition.

Whereas, the Joint Controller Legal Metrology Jammu Vide communication No.LM/JC/357/2014 Dated:13-11-2014 has requested to this Administrative Department that the office/routine work of Kishtwar District and more importantly the enforcement work in the district is suffering badly, as Sh.Anil Kumar presently posted in Udhampur District (transferred vide Government Order No.64 Of 2014 Dated:04-09-2014 to Kishtwar District) has not joined till date and is waiting for his reliever to join.

In view of the above, it is hereby ordered that in partial modification to the Government Order No.64 Of 2014 Dated:04-09-2014, Sh.Jaideep Singh Sambyal Assistant Controller(under transfer to Samba) is now posted as Assistant Controller Udhampur and Smt. Anita Sharma (under transfer to Udhampur) shall remain posted as Assistant Controller Samba in terms of the Hon'ble High Court Order dated:12-09-2014 passed in SWP No.2498/2014 titled Anita Sharma V. State and Others. Further, Sh. Sh.Anil Kumar presently working in Udhampur District shall be deemed to have been relieved in terms of Government Order No.64 Of 2014 Dated:04-09-2014 .
