Subject: - Constitution of Vigilance and Monitoring Committee to Check pilferage and to ensure proper distribution of ration amongst the rationees.

In supersession of Government Order No. 89-CAPD of 2015 dated 19.08.2015, sanction is hereby accorded to the constitution of village level Vigilance and Monitoring Committees to check pilferage and ensure proper distribution of PDs ration amongst the rationees in Department of Food, Civil Supplies and Consumer Affairs. The Committees shall work within their respective areas of jurisdictions i.e. villages/Govt. sales centers.

The committees shall comprises of the following:-

1.	Numberdar/Prominent citizens to be nominated by the Tehsildar concerned	Chairman
2.	Village level worker concerned/Area Inspector concerned within Municipal Limit	Member
3.	02 prominent local citizens, preferably retired Government Officers/Officials to be nominated by the Tehsildar concerned.	Member
4.	Storekeeper, Assistant Storekeeper/Salesman as the case may be	Member
5.	One member of each category i.e. NPHH, PHH and AAY category to be nominated by the Assistant Director, Department of Food Civil Supplies and Consumer Affairs	Member
6.	One member of SC/ST /Community to be nominated by the Tehsildar concerned	Member

The committee shall report to concerned Tehsildar and Assistant Director, Department of Food, Civil Supplies and Consumer Affairs on monthly basis.

The Utilization Certificate in format GFR-19-A of the FPS/Govt. Sale Centre will be signed by this Vigilance and Monitoring Committee. The tenure of the committee shall be one year from the date of issue of this order.


