01. All necessary Administrative Approvals and Technical Sanctions shall be obtained prior to the execution of works/projects. In case of cost revision, necessary revised Administrative Approval shall be obtained from the Competent Authority for incurring expenditure.
02. The expenditure shall be restricted to the administratively approved cost of the project /work only.
03. The funds released shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules.
04. No diversion of funds is allowed.
05. Scheme/projects already taken up shall have to be completed in maximum of two or three years time.
06. The progress achieved under the Scheme both in terms of Physical/ financial shall be communicated to the Administrative Department by 1st of each month.


