Subject:- WPPIL NO-09/2012 Titled Sheikh Mohammad Shafi Vs Union of India and others.

Government Order No ²⁶ - CAPD of 2016

Whereas, the General Administration Department vide OM No. GAD(Vig) 48-RDA 2013 dated 28-03-2014 has sought action taken report regarding enquiry bearing no Veri-BK-26/11 dated 10-08-2011 against Nissar Ahmed Zargar Assistant Director, CAPD Baramulla, Khursheed Ahmed Sher Khan Cashier CAPD Baramulla, Khursheed Ahmed Sanai, the then AD CAPD Baramulla and Reyaz Ahmed Wani the then AD CAPD north Baramulla, wherein allegation of Embezzlement/misappropriation of salary, rent, commission of CB Shop dealers were leveled against him; and

Whereas, pursuant to the OM Dated 28-03-2014 read with O.M. Dated: 09-04-2014 of GAD this department has asked Director CAPD Kashmir to furnish a detailed report in order to apprise the GAD; and

Whereas, the Director CAPD, Kashmir vide communication dated 06-05-2014 has furnished a detailed report that a case was pointed out by Assistant Baramulla regarding some financial irregularities/misconduct in his office due to negligence and dereliction of duties on the part of Mr. Khursheed Ahmed Sher Khan I/C Cashier and Daljit Singh, against whom Rs. 4.05 lacs were outstanding and has nothing said about the involvement of Khursheed Ahmed Sanai, the then AD CAPD Baramulla and Reyaz Ahmed Wani the then AD CAPD north Baramulla ; and

Whereas, vide Government Order No. 82-CAPD of 2015 dated 11-08-2015 Shri A.R.War Director Consumer Affairs and Public Distribution Department Kashmir was appointed as enquiry officer to enquire in to the alleged embezzlement /misappropriation of salary, rent Commission and CB Shops by Shri Nissar Ahmed Zargar the then I/C Assistant Director , CAPD Baramulla, Shri Khursheed Ahmed Sher Khan, the incharge Cashier and Shri Daljit Singh; and

Whereas, the above said Enquiry Officer has submitted its report vide No. DCAPDK/Adm/B-X-616 dated 08-02-2015 with the findings as under:-

" As reported by the Assistant Director Baramulla the outstanding amount has been recovered from Mr. Khurshid Ahmed Sher Khan and Daljit Singh (retired on 31-05-2007) in full. Pursuant to the Rule 30 of j & k Civil Service Rules, on month' s pay was imposed as fine vide Order No. DCA&PDK of 2015 dated 07-09-2015 against Mr. Sher Khan. The Official is discharging his legitimate duty with sincerely and sense of commitment and nothing adverse has been reported against him."

Now, therefore, in view of the above stated facts and circumstances, the enquiry report submitted by the Enquiry Officer is accepted and the enquiry regarding embezzlement /misappropriation of salary, rent Commission and CB Shops by Shri Nissar Ahmed Zargar the then I/C Assistant Director , CAPD Baramulla, Shri Khursheed Ahmed Sher Khan, the incharge Cashier and Shri Daljit Singh is hereby closed as the main culprit namely Mr. Khursheed Ahmed Sher Khan the then Cashier CAPD Baramulla and Daljit Singh has deposited the outstanding amount in full and serve the penalty of fine equivalent to his one month salary.


