**Subject:-Release of Commission charge to the Fair Price Shop Dealers.**

**Government Order No :- 312 -FCS&CA of 2017**  
**D a t e d :- 26, -07-2017**

In supersession of all previous orders on the subject, sanction is hereby accorded to the:

- a) Payment of commission charges @25% of admissible commission of Rs.143/- per quintal (State share) as per Rule 6 (1&2) of Notification No.GSR636 (E) dated:17-08-2015 of Union Ministry of Consumer Affairs, Food and Public Distribution, Department of Food and Public Distribution to Fair Price Shop Dealers under NFSA out of the Revolving Fund with effect from April, 2017;
- b) Payment of commission charge @Rs.143/- per quintal for the financial year 2017-18 under MMSFES & Tide over allocations w.e.f April, 2017.
- c) Payment of commission charges to FPS Dealers out of Revolving Fund @5% of sale rate value for foodgrains distributed for the financial year 2016-2017 under NFSA, MMSFES & Tide over allocations.

The payment of the commission shall be subject to the fulfillment of the following conditions:

- (i) That the Directorates shall meet this expenditure out of the Revolving Fund created in the Department during 2016-17.
- (ii) That the Directorates shall approach Administrative Department for budget provision in case of any deficit.
- (iii) That the Directorates shall regulate well the management and accounting of the Revolving Fund created for it in the financial year 2016-17.
- (iv) The Assistant Directors of the respective districts before making any payment on account of commission shall ensure and verify that the payment is being made as per the rates approved by the competent authority.


