In pursuance of J&K Services Selection Board's Order No.576-SSB of 2017 dated 23.10.2017 issued under endorsement No. SSB/Sel/Secy/2017/11078-81 dated 23.10.2017, sanction is hereby accorded to the temporary appointment of Ms. Navnidhi Sambyal D/O Shri Abinash Singh R/O Mandi Kehli, P.O, Tehsil and District Samba, as Junior Assistant, in the pay scale of Rs.5200-20200 with grade pay of Rs.1900/- in the Department of Food, Civil Supplies and Consumer Affairs, Jammu (Divisional Cadre Jammu).

The appointee shall report to the Director, Department of Food, Civil Supplies and Consumer Affairs, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

1. Academic Qualification certificate.
2. Age and Health certificate.
3. Date of birth certificate.
4. Permanent Resident certificate.
5. No Loan certificate under Self-Employment scheme from DIC concerned and Employment Department.
6. An undertaking in the shape of an affidavit duly signed by the Judicial Magistrate 1st Class to the effect that in case any adverse report about her character and antecedents is received from Police/CI, J&K, she shall have no right to claim for her appointment as Junior Assistant and her appointment, as such, shall to have been cancelled ab-initio.

The appointee shall be initially on probation for a period of two year and the confirmation whereof will be issued only after her satisfactory performance. If, on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-intio and criminal proceeding against the appointee shall be initiated.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of her character and antecedents are received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Department of Food, Civil Supplies and Consumer Affairs, Jammu.

The seniority of the appointee shall be determined as per the prescribed norms/rules.
