In continuation to Government Order No. 19-CAPD of 2013 dated 13-03-2013, sanction is hereby accorded to the release and advance drawal of additional funds to the tune of **Rs. 25.00 Lac (Rupees Twenty Five Lac only)** under the Sub Component “**Digitization**” of the scheme “End to End Computerization of TPDS Operations” of CA&PD Department J&K (e-PDS project) out of the Central Funds received vide above quoted reference and placement of the same at the disposal of FA/CAO Consumer Affairs and Public Distribution Department for its further release in favour of Commissioner/Secretary, Information Technology Department as **mobilization advance (3rd Installment)** for utilization during the year 2013-14 in respect of digitization of Ration Cards of the CA&PD Department in the State. The total funds released so far aggregates to Rs. 75.00 Lac.

The release of funds shall be subject to the following terms and conditions;

- (i) The funds released shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules.
- (ii) No diversion of funds is allowed.
- (iii) The funds shall be further released by the FA/CAO, CA&PD Department **after receipt of certificates of the digitized data from Director CA&PD Kashmir/Jammu and Incharge officer of State NIC.**
- (iv) The progress achieved under the scheme both in terms of financial/physical shall be communicated to CA&PD Department.


